

## **STANDARDS COMMITTEE – TERMS OF REFERENCE**

1. To promote and maintain high standards of conduct by the members and co-opted members of the Council.
2. To assist members and co-opted members of the Council to observe the Council's Code of Conduct.
3. To advise the Council on the adoption and revision of its Code of Conduct, taking into account, guidance and existing good practice within the Council.
4. To monitor the operation of the Code of Conduct and recommend revisions as appropriate, and to ensure that the Code is fully understood and applied throughout the Council.
5. To advise, train or arrange to train members and co-opted members of the Council on matters relating to the Code of Conduct.
6. To authorise dispensations to Members and Co-opted Members of the Council and other related authorities in accordance with the Localism Act 2011.
7. To carry out similar functions to those above in relation to those parish councils that have delegated their functions under the Localism Act 2011 to the Council, or where the Localism Act provides that the Council is the responsible Authority for such matters for which the Council is the responsible authority and the members of those parish councils.
8. To review arrangements as to the declarations of interest of members, co-opted members and officers, to monitor the operation of such arrangements and to offer advice on their application.
9. To review and recommend such other protocols, local codes and guidance as may be considered desirable to build upon the rules contained within the Code of Conduct whilst not forming part of it.
10. To establish a sub-committee: -
  - (a) to receive initial referrals from the Monitoring Officer upon complaints of failure to comply with the Code of Conduct and to make recommendations to the Committee with regard to whether the complaint should be investigated.
  - (b) To carry out the initial assessment of written allegations that members of the Council or of a parish council have failed to comply with the Code of Conduct.
11. To establish a Consideration and Hearing Panel, when required, to consider and determine allegations of breaches of the Code of Conduct that have not been locally resolved.
12. To consider any other recommendations, guidance or direction referred to the Committee or the Monitoring Officer.
13. To consider any application for exemption from political restriction made to the Committee by the holder of any post under the Council and to give

directions to the Council requiring it to include a post in the list of political restricted posts maintained by the Council.

14. To establish and monitor the operation of Complaints Procedures and Whistleblowing Procedures.
15. To review the application of the Council's Standing Orders, Financial Regulations, contract arrangements and other such provisions.
16. To review and comment upon the Council's procedures and codes of practice relating to public access to information, confidentiality and arrangements for data protection.
17. To review the procedures for appointment of Council representatives to outside bodies and to make recommendations to the Council or the Cabinet as necessary.
18. To consider reports arising from external inspections, audit investigations, Ombudsman investigations, legal challenges and other sources which cast doubt on the honesty or integrity of the Council, its members or officers, and to recommend action to the full Council or Cabinet as appropriate.
19. To consider and offer advice and guidance as appropriate on other matters which in the view of the Committee or the Council's monitoring officer could have a bearing on public perceptions of the honesty and integrity of the Council, its members, co-opted members and officers.
20. To consider and make recommendations on such other matters as the Committee itself thinks appropriate or which are referred for attention by the Council or the Cabinet which further the aim of promoting and maintaining the highest standards of conduct within the authority.

In these terms of reference "co-opted member of the Council" means a person who is not a member of the Council, but who: -

- (a) is a member of any committee or sub-committee of the Council, or
- (b) is a member of and represents the Council on any joint committee or joint sub-committee of the Council

and who is entitled to vote on any question which falls to be decided at any meeting of that committee or sub-committee.
