Guidance Notes For FULL PLANS SUBMISSION

DRAWINGS AND PARTICULARS

 Drawings shall be produced/presented in a clear and intelligible manner. Detailed plans and sections shall be to a scale of not less than 1:100 or, if the building is so extensive as to render a smaller scale necessary, not less than 1:200.
 Site plans shall be to a scale of not less than 1:1250 and shall show the siting of buildings within the site boundary and the location of the site in relation to surrounding properties. All submitted plans must now be dimensioned / scheduled in 'metric'.

GENERAL

- You can make your application by submitting your details online via www.submitaplan.com or emailing to building.control@rotherham.gov.uk If submitting by post, address to Riverside House, Building Control, Main Street, Rotherham S60 1AE.
 - It is important to remember that the **Plan Fee** should be submitted either by Debit Card or Cheque, otherwise processing the application may be delayed. Please Contact our Office on 01709 823847 to make a debit payment or post a cheque attaching a covering letter stating its purpose.

- 4. Regulatory reform (fire safety) order 2005. Does the building/extension work affect any of the following, Hotel/Boarding Houses/Offices/Shops/Railway Premises/Factories
- 5. A Completion Certificate will be issued only when the Local Authority considers that the building work has been satisfactorily completed.
- 6. In respect of applications for Replacement Windows/Doors, details are required of the existing and proposed windows/doors 'types'. To assist with this you could utilise/complete the form 'Replacement Windows/Doors Details'. Please request the form if required.
- 7. Section 16 of the Building Act 1984 provides for the passing of plans subject to conditions. The conditions may specify modifications to the deposited plans and/or that further plans shall be deposited.
- 8. To comply with Part P, you must either (i) use an electrician who is registered with a Competent Person's scheme (ask your electrician for details), in which case a Building Regulations application will not be required for the electrical work only; or, (ii) use an electrician who is registered with a recognised trade body such as NCEIC, ECA & NAPIT, etc.., and who will issue a 'design, installation and test' certificate under BS 7671 Building Control will then accept this as evidence of compliance but may also carry out additional inspections for verification. - 9. A Full Plans Application shall cease to have effect three years after deposit to the Local Authority unless the works have been commenced before the expiry of that period, in accordance with Section 32 of the Building Act 1984

OTHER APPROVALS

- 10. If the proposals set out in this notice are subject to the provisions of the Town and Country Planning Acts it will also be necessary for planning permission to be obtained before any work is carried out under a separate application.
