3.	Homelessness Prever	ntion and Housing Support		
3.1	Kim Firth (Homelessness & Temporary Accommodation Manager, Rotherham Council) updated on actions the Council is taking to look at immediately addressing the barrier recently identified in the Council's Housing Allocations Policy. She confirmed that the Council's Head of Housing Options is in the process of undertaking a light touch review and will be proposing to amend the Council's current policy which will remove the 5-year ruling in the policy. A Council Officer Decision Notice has been prepared and Members of the Covenant Group will be notified when this has been approved and the change to policy is implemented. <i>Post Meeting update: A Council Officer Decision Notice has now been approved and Policy updated in November 2023.</i>			

3.2	Kim also highlighted the following:	
	<ul> <li>There are 3 bands within the housing register – those protected by the Armed Forces Covenant get band 1 or band 2 priority, but emphasised the priority given it is still based on need across the borough.</li> <li>The Council's Homelessness Team carry out a weekly rough sleepers walk, every Wednesday at 6am – to date on these walks there has been no member of the Armed Forces Community presenting as homeless.</li> <li>The Homelessness Prevention Grant is still available and can assist with rent in advance and bond for those who qualify.</li> </ul>	
3.3	A summary on the latest position of available accommodation / housing stock in Rotherham was also provided and confirmed there were 722 voids relet between April – September, 87 households secured a direct let; of the cases presenting as homeless, 179 secured a Council house, 24 Housing Association, 44 into supported living and 122 went into private rent.	
3.4	Kim also reported on the recent Catcliffe floods and support the Council is providing to residents. Vicky Hartley confirmed that colleagues in the Council who are out on the ground supporting communities are asking the question to identify if there are any members of the Armed Forces community affected and to date no one has identified. <i>Post Meeting Update: Help4Homeless Veterans Charity confirmed they would be</i>	
	providing small grants of $\pm 300$ to any members of the armed forces community impacted by the floods.	
4.	Rotherham's Armed Forces Community Covenant Group Action Plan	
a)	Updates against activity set out in the Action Plan	
4.1	Vicky Hartley reported that delivery timescales had now been included for activity set out in the Action Plan as requested at the last Covenant Group meeting.	
4.2	She also reported that a new Armed Forces Strategic Group had been established in the Council which consists of senior management from all lead service areas across the Council (Adult Social Care, Public Health, Housing, Education, HR, Customer Services, Neighbourhoods etc). The Group is chaired by the Assistant Chief Executive and will have oversight for ensuring the Council's support for the armed forces and requirements in relation to the Armed Forces Covenant Duty is fully embedded into all mainstream services.	
4.3	The main area where significant progress has been made in relation to the Action Plan was in relation to Housing as reported earlier in the meeting (item 3).	
b)	Loneliness – engaging with the armed forces community	
4.4	<ul> <li>Vicky Hartley presented a paper on behalf of Ruth Fletcher-Brown, the Council's Public Health Specialist who was unable to attend the meeting. The paper set out the Council's Loneliness Action Plan which has been signed up to by all Health and Wellbeing Board partners and identifies one of the actions within the Plan to understand the needs of specific groups / communities who are more at risk of loneliness. Given the Armed Forces Community is identified as a group that is more at risk of loneliness, Rotherham Public Health want to engage with the local Armed Forces Community and run some Focus Groups with the intention of the findings to:</li> <li>Incorporate into a Loneliness Chapter in the JSNA (Rotherham Health Data Hub).</li> <li>Used to help inform Commissioners and Providers about the needs of these communities.</li> <li>Incorporated into Making Every Contact Count Loneliness training for staff and volunteers across Place.</li> <li>Develop specific actions to address this.</li> </ul>	
	Covenant Members were very supportive of this approach and Public Health conducting this piece of work.

	the timings for the next seminar could be extended. Ron reported that he was disappointed to note that there was lack of representation from veterans charities despite	
	being invited, however overall the seminar was a great success.	
7.	Covenant Group Member Updates	
7.1	Steve Bentham- Bates, Help for Homeless Veterans	
	There was no representation from the charity at this meeting, but a short summary report was read out by Emma Colley, Member and Civic Support Officer at Rotherham	
	Council on behalf of Steve Bentham Bates.	
	Since the last meeting in August 2023, Help for Homeless Veterans has helped 11	
	Veterans (5 of which had links to Rotherham). The financial support includes: emergency B&B, rent payments, food and furniture. An application has been	
	submitted for the grant to continue the free veterans visits to the Veterans Therapy	
	Farm in 2024 and is currently awaiting a decision.	
7.2	Hannah Hall, Rotherham NHS Foundation Trust	
	Funding has been successful for a full-time post (Armed Forces Welfare Advisor) and all being well recruitment will start within the month with a view to the role	
	commencing in January 2024.	
	Rotherham NHS Foundation Trust has been invited to input on the Forces Connect	
	App which is an app that anyone can get on their phone, device or computer to tell them about the support services available locally for the armed forces community.

### 7.3 Major MP Lynch, The Royal Yorkshire Regiment

November is a busy month for all the Remembrance Services – the 5<sup>th</sup> Battalion will be attending a Regimental service at York Minster and taking part in the marching contingent at London as part of the Remembrance Parade. Currently there are troops deployed to Iraq and Estonia. Major Lynch also reminded the group that every serviceman has access to a benevolent fund which helps those struggling due to the cost-of-living crisis, £100k was given out last year, which RBL matches 100% and SSAFA coordinates.

## 7.4 Cllr lan Jones, Rotherham MCVC

Further funding has been secured from the National Lottery to fund Chris Bradley for a further 2 years. MCVC are also looking at appointing a part-time admin post and are also working on implementing a database and are looking into a data sharing agreement with other partners. The database will take around 18 months to get up and running. The daily drop-ins have now increased thanks to additional funding. MCVC have been supporting VAR at Catcliffe following the recent floods, in providing teas and coffees to those affected. MCVC are also working on loneliness and isolation amongst veterans and working with organisations, including the Citizens Advice Bureau at Doncaster to help identify veterans affected by those issues.

#### 7.5 Elaine Mason, Op Nova / Forces Employment Charity

There is still a significant amount of casework and Op Nova will be having its Regional Launch at Manchester in November.

### 7.6 Amanda Naylor/ Danella Senior, OpCourage North

Now working under an integrated service with one pathway and working on building links, sharing information and ensuring working from a joined up approach. Would welcome an opportunity to provide more of an overview of the work of the Trust at the next meeting of the Covenant Group.

Employee Recognition Scheme Gold status has recently been awarded to the Trust and an awards ceremony will be held in November for the presentation of the award. The Trust will also be holding a Remembrance Service on 12<sup>th</sup> November.

#### 7.7 Pauline King, Reserves' Forces & Cadets' Forces Association for Yorkshire and Humber

Submissions will be open from the 9<sup>th</sup> January with deadline of end March for the Employee Recognition Scheme awards. There may be some changes to the submission process and this information will be rolled out once available.

Following the success of their first joint Cadet Careers Fair earlier this year, they are now planning for next year's event which will be held on Saturday, 10<sup>th</sup> February in York. The aim of the event is to bring members of the Sea Cadets, Army Cadet Force and Air Training Corps, aged 15<sup>1</sup>/<sub>2</sub> -18, from across all of Yorkshire, the Humber and North East Lincolnshire.
