<b>9.</b> Any body:- <b>(a)</b> exercising functions of a public nature; <b>(b)</b> directed to charitable purposes; <b>(c)</b> one of whose principal purposes includes the influence of public opinion or policy (including any political party or trade union); or <b>(d)</b> which is a private club or society, such as the Freemasons, a recreational club, working men's club or private investment club of which you are a member or in a position of general control or management.	
<b>10.</b> Any person from whom you have received a gift or hospitality with an estimated value of at least £25.	

### Declaration

I understand that it is a breach of the Code of Conduct to fail to notify the Council's monitoring officer of any personal or disclosable pecuniary interest:-

- (a) within 28 days of becoming a member or co-opted member of the Council;
- (b) within 28 days of acquiring any new interest or becoming aware of any such interest;
- (c) within 28 days of any change to an interest that you have previously registered or
- (d) within 28 days of disclosing an interest at a meeting of the Council.
