Ref 3.2 - Designation of the Neighbourhood Area – Neighbourhood Planning (General) Regulations 2012 (as amended).

The Council can confirm that the Regulation 5, 6 and 7 requirements have been satisfied. Please see further information in the table below.

Confirmation and evidence has been requested that relevant (Schedule 1) Consultation Bodies that were consulted at Regulation 14 stage by the Town Council were notified as part of the Regulation 16 Publicity by the Council.

I am pleased to attach further information on the Regulation 16 Publicity carried out by the Council in Appendix 2; the bodies shown in Column 2 of this table were also consulted by the Town Council at Regulation 14 stage.

The Council mailing list for the Regulation 16 publicity, comprised of the bodies listed in the "Dinnington St John's Neighbourhood Plan 2016/2028 - Consultation Statement (June 2019)" plus further contacts held on the Local Plan data base. The Council created a mass mailing list from this consultation. On cross referencing the respective mailing lists from Regulation 14 and 16, four bodies were identified that the Council cannot provide proof of consultation notification (as part of the Regulation 16 Publicity).
