Any body:- (a) exercising functions of a public nature; (b) directed to charitable purposes; (c) one of whose principal purposes includes the influence of public opinion or policy (including any political party or trade union); or (d) which is a private club or society, such as the Freemasons, a recreational club, working men's club or private investment club of which you are a member or in a position of general control or management.

Declaration

- (a) within 28 days of becoming a member or co-opted member of the Council;
- (b) within 28 days of acquiring any new interest or becoming aware of any such interest;
- (c) within 28 days of any change to an interest that you have previously registered or
- (d) within 28 days of disclosing an interest at a meeting of the Council.
