#### Location

The site is located off Henley Rise, Masbrough, Rotherham, approximately 0.5 miles from Rotherham town centre and 3 miles from Junction 36 of the M1.

#### Description

The site comprises approximately 2.38 acres of grazing land as shown edged green on the attached plan. Vehicular access to the site is provided directly off Henley Rise. Some work is required to bring the land up to a suitable standard for grazing; therefore a viewing is strongly advised before placing an offer. The land is being offered in it's current condition, no works will be undertaken by the Council prior to letting.





#### Measurements

Approximately 2.38 acres / 9,632 m2 or thereabouts.

#### Water Supply

There is currently no water supply to the land . The tenant will therefore require a bowser or similar. However, access to water can potentially be supplied at the discretion and through agreement directly with the Allotment society at a rate to be agreed by both parties.
