

Independent auditor's report to the members of Rotherham Metropolitan Borough Council (the "Authority")

Issue of audit opinion on the financial statements

In our audit report for the year ended 31 March 2020 issued on 4 December 2020 we reported that, in our opinion the financial statements:

- give a true and fair view of the financial position of the group and of the Authority as at 31 March 2020 and of the group's expenditure and income and the Authority's expenditure and income for the year then ended;

- have been prepared in accordance with the requirements of the Local Audit and Accountability Act 2014.
