The Maltby Neighbourhood Plan Submission Version was submitted to Rotherham Metropolitan Borough Council on 30 March 2023.

The Council undertook consultation on this document, in accordance with the requirements of Regulation 16 of The Neighbourhood Planning (General) Regulations 2012, between 30 June and 21 August 2023.
