3. Housing & Homelessness

- 3.1 Cllr Eve Keenan, Rotherham's Armed Forces Champion introduced and welcomed the Council's Assistant Director for Housing, James Clark and Head of Housing Options, Sandra Tolley to the meeting.
- 3.2 Presentations were delivered on the Housing Options for Veterans (delivered by James Clark and attached at Annex A) and on the Council's Housing Allocation Policy Review (delivered by Sandra Tolley at Annex B).
- Following the presentations, discussions took place, and a summary of issues raised were as follows:

Housing Options for Veterans

- The pathway for the armed forces community is often difficult with housing and homelessness for the armed forces community continuing to be a challenge as the local connection rules differ for allocations and homelessness.
- The process to register on the housing register with local Councils is not consistent and varies.
- Veterans find it hard to register and it would be helpful to have some further information on how the Council can assist with the registration process.
- There appears to be very little housing priority given to veterans on health grounds. It was noted that all Councils are different but there is national guidelines to the Local Connection Criteria for Allocations.
- New build proposals in the borough were welcomed an example case was highlighted and given in relation to exclusions from bidding for new build due to not being a Council tenant.
- The Council needs to make best use of its stock, for example, ensure age is an assessment criteria, sheltered accommodation sits within the policy and that people over 50 are assessed (young people access to ground floors / allocate 4 bedrooms house to large families). Noted that Rotherham Council allocates bungalows on a shared basis given some veterans have lost limbs and need ground floor e.g. the 50% on need irrespective of age. An example was provided in relation to Sheffield criteria being 60 plus.
- Highlighted that the Council owns 20,000 homes and there are a lot through the 'Right to Buy' initiative. It was noted that the Government has recently pledged to 1.5m new homes and that rules have been changed to make it more difficult to 'Right to Buy'.
- Refresher training for officers in the Council and the development and introduction of process maps for officers to refer to setting out the processes in relation to existing housing / homelessness policies were welcomed. It would be helpful for the Covenant Group to work with the Council on expanding the process map for the armed forces community.

Housing (page 5) 5.3 New regulations came in on 18 December 2024 for all Local Authorities to accept Veterans from anywhere in the Country. Rotherham's Policy for Veterans had already been updated in November 2023, and Rotherham's Policy already includes exceptions to Local Connection for Veterans for applications for social housing. Housing Application and medical assessment asks the question if ever served and asks if a family member of a current member of the armed forces. Appointment of a specialist Homelessness Officer for Veterans within the Council to act as a lead point of contact for the armed forces community. At 7/2/2025 the Council reported there are 176 applicants on the housing register that are noted as having served in the armed forces. This is relatively low given there are 7,000 currently on the register. The homelessness team are referring veterans to Op FORTITUDE who may be able to find supported accommodation for veterans. Process maps for Council officers to refer to and refresher training delivered. Health & Well-being (page 8) 5.4 Recommendation from Rotherham Mental Health Needs Assessment 2023-24 - Dr Connie Hobbs in the Council's Public Health Team has been liaising with Amanda Naylor, Op Courage in Veterans Mental Health and Wellbeing Service at Leeds and Yorkshire Partnership NHS Foundation Trust. This is to ensure the profile is raised on specialist veteran mental health services and they are linked in with other services to raise their profile amongst the target population and promote their uptake. **Combatting Loneliness and Isolation** 5.5 Vicky Hartley, Rotherham Council reported back on the work that the Council has been leading on arising from Focus Groups held last year with the armed forces community via Rotherham MCVC and with the Council's Public Health Specialist. 5.6 A flyer detailing the current support has been developed by key leads in the Council aimed to assist with combatting loneliness and isolation and improving mental health & well-being. The flyer included as part of the agenda pack for this meeting details the current support that is available, how the community can stay connected and highlights when key events take place in Rotherham. 5.7 It was agreed the flyer be circulated through email outside this meeting to enable all Members of the Covenant Group given not all in attendance at the meeting to provide feedback. Once feedback has been received and the flyer finalised, this will be printed and be made digitally available to all Covenant Group Members to Vicky Hartley request that this be widely distributed amongst key networks.
