

STATEMENT OF REPRESENTATIONS PROCEDURE

PUBLICATION OF DINNINGTON ST JOHN'S NEIGHBOURHOOD PLAN PROPOSAL

In accordance with Regulation 15 of the above Regulations Dinnington St John's Town Council as a qualifying body has submitted to Rotherham Metropolitan Borough Council:

- A copy of the plan proposal (including a map of the area to which the plan relates);
- A consultation statement;
- A basic conditions statement;
- A Strategic Environmental Assessment Screening and Habitats Regulation Assessment Screening Report, and accompanying Addendum; and
- Supporting evidence base documents.

Rotherham Metropolitan Borough Council is now required (Regulation 16) to publicise details of the plan proposal and invite comment ahead of the submission of the plan to independent examination.

Consultation period: The Council is seeking your comments on the Dinnington St John's Neighbourhood Plan proposal from **7 November until 5pm on 20 December 2019**. Representations received after this deadline will not be taken into consideration.
