


# RMBC and town and parish council Joint Working Group 2016 to 2017







### Introduction



he principle consultative group between RMBC and the parish and town councils is the Joint Working Group. The group was originally set up in 2006 due to recognition of the benefit to both tiers of local government including: a joint working charter, improving communications, and the offer of training and development opportunities.

Today, the group consists of eight elected representatives from parish and town councils, and relevant RMBC officers. It is chaired by myself as Cabinet Member of Neighbourhood Working and Cultural Services and serviced by the Neighbourhood Partnerships Team.

The group meets every six weeks with RMBC officers to contructively solve issues being experienced by parish and town councils. The following is an overview of the work progressed by the joint working group between July 2016 and June 2017.

# Overview July 2016 to June 2017

Road Closures and License Costs

The Assistant Director Community Safety and Street

Scene, Highway Network Group Manager, and Inspection and Enforcement Manager provided clarification on procedures for road closures and the costs involved. This has led to improved communication with the parish and town councils and this service.

Planning Objections and procedures Clarification on procedures with regards to objections to planning applications have been pursued with the Head of Service for Planning and Building Control at the Joint Working Group meetings. Two Introduction to Planning sessions have taken place giving opportunities for all parish and town councils to take part. The sessions were delivered by the Local Planning Authority with the Chair of the Planning Board and the Planning Lawyer. The sessions were very well received by attendees.

**Licence applications and consultations** The Business Regulation Manager provided clarification on premises licensing and the application process – this led to resuming consultation service with local councils concerning licence applications for their areas.

**Rate Support Grant** The Strategic Director for Adult Care and Housing, and the Strategic Director for Finance and Customer Service have clarified the situation concering the phasing out of the support grant and provided an offer of support to local councils for budgeting for the next financial year.



#### RMBC AND TOWN/PARISH COUNCIL JOINT WORKING GROUP 16/17



**Community Asset Transfer** The Strategic Director for Regeneration and Environment, and the Corporate Property Manager clarified the current procedures for transferring assets the Council's current position with overcoming service issues being experienced by some of the parish councils.

Police Locality working Chief Inspector South Yorkshire Police provided confirmation on commitment to working with local councils and to improve communication concerning commitment to events and activities organised by local councils. Parish and town councils have since been contacted for a list of their activities and events were they would like police presence and have been given up-to-date police contact list for their areas.

**Boundary Review** The Democratic Services Manager and Principal Policy and Partnership Officer delivered an update on the Local Government Boundary Commission's ward boundary review and details on how the local councils can have a say in the consultation process. This information was circulated to the parish and town council network.

**Neighbourhood working review** The Strategic Director for Adult Services and Neighbourhoods provided an outline of the proposals for neighbourhood working.

Focus group work
Through the Joint Working Group, a number of parishes have come together to meet in the South of the Borough to look at ways to enhanced enforcement with regards to litter, dog fouling, and traffic offences. The group liaises with RMBC and South Yorkshire Police on a regular basis.

# Training and development for parish and town councils

All town and parish councils based within the Rotherham Borough have had the opportunity to attend a range of quality training and information awareness sessions over the past year. The sessions have been requested by members of the Joint Working Group and local councils from the wider network and have provided a forum for learning, networking and building relations. Provided free of charge, there has been no cost to the parish and town councils. All sessions were delivered by RMBC specialist services, these being: Planning Policy Team, Legal Services, and the Emergency and Safety Team. Planning Aid England supported the network conference held last November.
